Weston & Sampson is pleased to present a preliminary cost estimate for abatement and demolition services of the Hydeville Mill Site located at 108 Hydeville Road in Stafford, Connecticut. This estimated cost is based on very limited information available as the buildings are unsafe to enter and assumed to require bulk loading. Assumptions were made based on limited information gathered during our June 2023 Phase II Environmental Site Assessment (ESA) and Hazardous Building Materials Inspection (HBMI). We estimate that abatement and demolition costs will range between \$680,000 and \$910,000. Attached is a breakdown of the estimated costs.
