Chairman Edward Muska was unable to attend the meeting due to an emergency. Commission member Lida Miller moved to appoint Henry J. DaDalt as acting chairman. Linda Hillebrecht seconded the motion which passed unanimously. Acting Chairman Henry DaDalt called the public hearing to order at 6:00P.M. Members Linda Hillebrecht, Henry J. DaDalt, Steven Agostinucci and Lida Miller were present. The call of the meeting was read.

First Selectman, Richard Shuck and Director of Public Works, Richard Zulick were also in attendance to discuss any issues or concerns that the Commission has in the Service District area that public works could assist with.

Commission member Lida Miller asked about the Grant Avenue / East Main Street sidewalks and the use of asphalt vs. concrete. There was much discussion regarding the cost of concrete vs. asphalt and which product lasts longer. Mrs. Miller also stated that she has had numerous people express to her that the stamped concrete is not good, the concern was that the stamped surface makes it hard to walk on. Director Zulick explained to the Commission that DPW could assist with asphalt sidewalks as they have the proper equipment to do so.

The Commission also discussed with the Public Works Director the different area sidewalks that they feel are in the greatest disrepair. Highland Terrace was unable to be done last fall as hoped so that project will be done this spring. The next area of sidewalks that they hope to see done next is Olympic Avenue. First Selectman Shuck explained that the area has numerous issues with bad sidewalks and dying trees.

The Commission discussed the proposed expenditures for the Fiscal Year 2014-2015 Service District.

MINUTES:

Members Present: Henry J. DaDalt, Steve Agostinucci, Lida Miller and Linda Hillebrecht. A quorum was established. Due to an emergency Chairman Edward Muska was not in attendance.

Upon motion of Lida Miller and seconded by Linda Hillebrecht the Commission unanimously appointed Henry J. DaDalt to sit in as the acting chairman.

Also in attendance was First Selectman, Richard Shuck and Director of Public Works Richard Zulick.

Acting Chairman DaDalt called the meeting to order at 6:30PM and reviewed the proposed Service District budget with the members.

The Commission discussed the proposed expenses for the 2014-2015 Fiscal Year and the increased mil rate. Options were discussed for taking more out of the Service District cash balance to offset the proposed mill rate increase. Following some discussion, the commission members agreed that this would bring the cash balance to low.

Lida Miller moved to send the amount of \$400,215.00 (total operating budget) noting the total to be raised from taxation would be \$355,215.00 requiring a proposed mil rate of 2.39 to the Board of Finance. Linda Hillebrecht seconded the motion which passed unanimously.

Linda Hillebrecht moved to adjourn the meeting at 6:38P.M. Stephen Agostinucci seconded the motion which passed unanimously.
